These statements show how the Department is spending its funds. We issued a qualified opinion on the Department's FY 2000 consolidated balance sheet and statement of net cost. In addition to material weaknesses for property accounting and information security, we identified seven FY 2001 issues involving internal control weaknesses and compliance with laws and regulations. While these are important, they did not affect our audit opinion.
